

# HOW CAN YOU HELP?

## IMMEDIATE NEEDS

- \* **Individual sponsorships** to high school for deserving students leaving 9th grade who didn't win the one annual scholarship. This would be your student, boy or girl, and you would communicate directly with him or her. Cost: Estimated \$950 per year, with a 3-year commitment required. Please note that under the new system, high school in Kenya is now 3 years rather than 4, beginning in January 2026.

## CONTINUING NEEDS

- \* **Computer studies teacher/librarian.** Cost: \$2450 per school year
- \* **Ngandu's Angels scholarships** for top student graduating each year from 9th grade. Cost: About \$2850 per year to keep three students in residence high school concurrently
- \* **Sanitary napkins** for girls in order to facilitate their staying in school and attending classes. Cost: \$1130 per year, including delivery from Nairobi
- \* **Abdul Hamid Wildlife Day.** Hires a school bus and pays conservancy entry fees for the annual outing to Sweetwaters for the top four and most improved in Classes 5 through 9. Cost: \$650
- \* **Wi-fi service.** Cost: \$500 per year

## ABOUT YOUR DONATION

Ngandu's Angels is operated by a Board of Directors consisting of Michele Burgess and her three sisters. Directors are unpaid volunteers, and we have no paid staff. In Focus with Michele Burgess pays all expenses other than bank and government fees, so that virtually 99.9% of your donation goes to improving the facilities, services, and education at Ngandu School, or for providing high school scholarships.

We were assessed a monthly fee plus an annual "compliance fee," even if we had no credit card transactions. This is not where we want our money to go.
